#### INDEPENDENT AUDITOR'S REPORT

## To the Members of MIDLAND TOWNSHIP PRIVATE LIMITED

#### Report on the Standalone Financial Statements:

We have audited the accompanying standalone financial statements of MIDLAND TOWNSHIP PRIVATE LIMITED ("the Company"), which comprise the Balance Sheet as at March 31, 2016, the Statement of Profit and Loss and the Cash Flow Statement for the year then ended and a summary of significant accounting policies and other explanatory information.

## Management's Responsibility for the Financial Statements:
